



Federal

- -Regulate corporations






State vs. Federal Advocacy



REPEAL ACT HIV Discrimination Act

(Repeal of Existing Policies that Encourage and Allow Legal HIV Discrimination)

- Reintroduced March 27, 17 by Rep. Barbara Lee (D-CA) and Rep. Ros-Lehtinen (R-FL), 33 other cosponsors
- Directs Attorney General, Dept. of HHS and Dept. of Defense to initiate review of federal (including military) and criminal state laws, policies and regulations involving criminal and civil commitment of PLHIV
- AG and HHS to develop and release guidance on best practice recommendations for **states** to reform laws to reflect evidence-based and medically accurate understanding of the routes risks and transmission of HIV.





State-based HIV Criminalization Advocacy



June 6, 2016 - PWN-CO members and other advocates with Colorado state legislators and state Governor to sign a bill changing Colorado HIV criminal laws



Jan. & March 2017 – PWN-SC trains the trainers and then educates the community about HIV criminal laws in South Carolina





Nuts and Bolts

- Most state legislatures mirror the U.S. Congress
 - (with some changes)
- Know your neighbor's politics!
- Learn your basics:
 - Which party controls the House/Senate?
 - When is the deadline for pre-session bills?
 - Is there a deadline for presenting new bills?
 - When must bills pass to the opposite house?
 - What committees exist within the legislature?
 - What are the rules around special sessions?
 - Go to public hearings or watch online!
 - Find out when campaigning starts

Make Friends!


- Community organizing is diverse
 - Volunteer
 - Join coalitions
 - Create a coalition
 - Go to city counsel meetings
 - Meet the "policy wonks" in your state
 - Call the radio
 - Take a free training
- Track legislation as a team or by yourself
- Most importantly: use your question gun





Play the Game; Work the Maze

- Find groups with resources
 - Bonus points if they have a lobbyist
- Policy work is a maze—work from the end result backwards
- Be detail oriented
 - National bill templates will need to be altered to make sense locally
 - Study your behind off
- But also think BIG
 - Maybe a bill isn't the first step. Try a local ordinance or resolution
- Be introspective.
 - Learn about yourself and your strengths. You're already a perfect lobbyist for your own cause!

 - Resilience is a requirement!

- Build up your community to build up yourself

Mission & Vision


- Our mission is to develop a social change movement dedicated to the health and wellbeing of Black women and girls through leadership, Human Rights & Reproductive Justice

Women's Health in PA

- "Pennsylvania stands out as one of the states that are among the worst in the nation for women." – Center for American Action Fun, The State of Women in Pennsylvania
- PA is failing women when it comes to their economic security, leadership, and health.
- Meanwhile elected officials in Harrisburg are preoccupied with trying to restrict access to reproductive health care.



- Advocating for evidencedbased solutions to the problems.
- 55+ local, state and national organizations working together to improve women's health and economic security in PA.

Agenda for Women's Health

- A package of proactive bills that address women's physical health, financial security, and personal safety.
- Sponsored and supported by the Women's Health Caucus of the PA legislature.
- The first wave of Agenda bills was introduced in December 2013.

Agenda for Women's Health

Victories

- Act 200: Equitable protections for domestic violence survivors
- HB 1901: "Revenge porn" law

2017-2018 Session:

- Reasonable accommodations for pregnant workers
- Patient Trust Act
- Increasing the minimum wage
- Uniform reporting of crimes on campuses
